Reference Points of Local Public Administration in the Republic of Moldova

1. Introduction

Since the disintegration of the Soviet Union in 1991, Moldova became an independent country that started to build its future. It was necessary to introduce a new national legal framework based on a highly developed country's experience, and on the cultural and national traditions of Moldovan nation. Further tasks included the formation of a national identity and the creation of an economic system based on market relations, and the integration of the Republic of Moldova into the European Community and other international bodies.

Among the most important reforms, the efficiency of which depends on the successful implementation of all the country's reorganization, continues to be the creation of a new structure of state and local administration adequate to the democratization

processes of all domains of the society.

2. Reform background:

From the chronological point of view, three periods can be identified during which efforts have been undertaken in order to create a local public administration system.

First period (1991-1994). This stage is also known as the 'transition period', as its essential measures were aimed to eliminate super-centralized forms of governance and to create the necessary conditions for the implementation of a modern, civilized local administration. Furthermore, it deserves mentioning that all the activities of central public administration bodies have been performed in similar conditions, subject to the continuous transformations caused by the political instability persisting in the Republic.

An important step towards the creation of a legislative framework of public administration constituted the adoption of Republic of Moldova Constitution (29.07.94), which has established the central and local public administration basic principles. There are established provisions that came into concordance with the European Charter stipulation "Local Power Autonomous Exercise".

Second period (1994-1998). This period commenced with the adoption of a set of laws regarding local public administration and continued with the implementation of these laws. Accordingly, on 7th December 1994 the Law on Local Public Administration that authorized

the local governments with autonomy, the Law on Administrative Territorial Organization of the Republic of Moldova and Law on Local Elections were adopted.

At the beginning, the local public authority's autonomy used to be mainly declarative. The Republic of Moldova Parliament ratified the European Charter "Local Power Autonomous Exercise" only in 1997.

Third period (1998 - to date). This period is characterized by efforts undertaken to adjust the reforms of local public adminis-

have stepped into a new way: from a hypercentralized system – to a democratic governance system.

The self-administration concept has three essential elements. First one is *local autonomy*, dealing with power vertical separation and the decentralized settlement of local issues.

The second element is *due* extension of local administration that refers to local interests' issues. Real autonomy demands that public interest issues have to be solved on the spot.



tration to the new social-economic conditions of the developing society. Thus, on 6th November 1998 the law on public administration and on 12th November 1998 the law on Administrative Territorial Organization of the Republic of Moldova was adopted. Another law that establishes locality statute in administrative-territorial units of the second level was adopted on 19th February 1999. Accordingly, with a sevenyear delay, local public administration reform seems to be motivated from the legislative point of view.

3. The Centralization To The Decentralization:

After the totalitarian regime had collapsed, most Eastern and Central European countries

The third element is *local* democracy. Local public authorities as elected bodies, perform an institution of representative democracy, in which local self-administration is usually exercised by means of a corporate body. In addition, local self-administration also includes the possibility of organization of consultations with citizens (local referendum).

These three elements of a local self-administration concept establish who will exercise self-administration, and how and in what manner. They express common recognized values that can be found in the Constitutions of European democracies and in the Local Self-Administration Charter, adopted by the European Council in 1985.



At present, according to the new law, the country is devised into nine counties: Bălți, Cahul, Chișinău, Edinet, Lăpușna, Orhei, Soroca, Tighina, and Ungheni. Some localities from the Southern part of the Republic constitute an autonomous territorial unit with a special statute established by an organic law. Administrative organization of the Republic of Moldova territory is being performing on two levels: villages (communes) and towns (municipalities) constitute the first level, and counties, the autonomous-territorial units of Găgăuzia and Chișinău municipality constitute the second level.

The county has a Council, that elects the County Council Chairman and a permanent bureau. The permanent bureau is formed of approximately 11 members, including the Chairman, several Vice-Chairmen and the Secretary. They are supported by a number of departments responsible for various domains such as for example: education, social services, and finance.

4. Domains seeking improvement:

• Knowledge and Experience

Local authorities must be formed by persons possessing good knowledge and capacities, who prove the necessary commitment to fulfill obligations. 66

Local public servants have to understand whom they represent and what is the goal of their work. The Public Servants' statute has to be re-vitalized by the reforming, at least, of the Law on Public Service. In order to surpass knowledge and experience issues, training may be a good solution.

The creation of a national training system in which highly qualitative institutions would propose qualitative training could assure a better preparation for officers engaged in this domain.

• Co-operation between Local Authorities

Co-operation between local authorities has to be stimulated. First steps in the creation of local authorities associations have been undertaken. Like for example, the Moldovan Mayors' Association, but activity of such has to be sustainable in order to create a strong association, that could really guarantee the local communities' rights. It is necessary to adopt a law, that would provide and stimulate cooperation between local authorities.

• Elaboration and Adoption of the Entire Set of Laws on Local Public Administration

Local public authorities functions and organization principles need to be supported through the adoption of the entire set of normative and legislative acts. For example local public finances, local public patrimony, administrative cotentiousness, Chisinau municipality statute, as well as regarding regulations, framework-statutes, instructions, and directory recommendations.



"Niepołomice – the Success of the Municipal Authorities in Poland During the Transformation Period"

In May 1990 all the communes received self-independence and newly elected people took over the authority. Those people believed that after rearranging the organisation from the predecessor, many good things could be done for their local community.

Background

The new organization, which took over the Niepołomice Town and Community found that the previous administration was a headache for the public administration employees. Though not large, a 20,000 inhabitants community, (a distant 25 km from Krakow centre - the capital of Małopolska region) did not have the proper functioning communal housing and sewage infra-structure. There was also no phones and a functioning transportation system. Apart from that, the green resources were governed from the City of Krakow and the decisions about waste disposal were taken in Wieliczka.

During 1991 –1992 the community had to pay the high cost of the political system and economic transformation. As a result of the collapse of large companies such as: "Igloopol", "Motoruch", "Cracow's Poultry Factories" and "Kombet" about 1700 workers lost their jobs. The situation was exacerbated when additionally about 1500 workers of the T. Sendzimir Steelworks lost their jobs. Consequently in the 20,000 commune there were about 3,000 people without any work.

New Local Management

The new municipal authorities started by making a stocktaking list

in their community. The author of a so-called "the commune photo" - the stocktaking list, which was delivered to each home, was the Leader and the Mayor of Niepolomice, Mr. Stanisław Kracik. Thanks to his attitude the commune inhabitants believed in their success and they overcame "the little town syndrome of aversion to changes". The Mayor said that it was necessary to simultaneously build new schools, kindergartens, to create new jobs, to develop the agriculture and to support the local initiatives, and not simply to create any priorities in the commune's economic development.

When the Coca-Cola Company was looking for a site for its new factory in Krakow and its surroundings, the Mayor took the opportunity to propose the Niepolomice commune. He showed the visitors the site at the outskirts of the town, simultaneously assuring them the law of land possession without any other participating investor and without the need of road building, like other tenderers wanted, would be granted.

The Coca-Cola Company chose the commune of Niepołomice and the commune has benefited with new jobs. The commune's profits has also increased from the estate taxes and in addition from the income from the employees.

The commune of Niepołomice has taken the opportunity of possession communisation and free estate disposal. The next benefit was the purchase of the bankrupt factories and then they were sold and with the profits the new companies were established.

The commune authorities have used the advantage of not leasing the properties but have used the privatisation process to commence the selling of the commune properties.

The commune authorities prepared the land and properties for the new investments. The Mayor has full power of the authorities and he can lead the negotiations with investors. The investors can be equally Polish or foreign ones.

Economic Results

Thanks to the leading of the investment economy the number of registered companies increased quite considerably from 700 in 1991 to 1051 in 1995 and even reached 1200 in June 1998. As the result of such economic development, the inhabitants do not have to search for a job in Krakow or in steelworks in Nowa Huta.

Undoubtedly the indicator of the economic development of the commune is the income per capita. In Niepołomice the commune income per capita still increases systematically and in 1991 it was 162 PLN per capita, in 1995 – 844 PLN per capita, in 1996 – 891 PLN per capita, in 1997 – 1112 PLN per capita and finally in 1998 it reached 1422 PLN per capita.

Thanks to the Mayor's and the authorities' good economic management and administration and also to the taxes received from the local companies, the commune of Niepołomice was, in 1996, in the top twenty towns with the highest commune income per capita.

Nowadays many public administration officials consider the phenom-

ena of how it was possible that a 20,000-inhabitant commune reached the commune income per capita higher than the other 40,000 in the Małopolska Region. When those officials come to Niepołomice they always convince themselves that the right location of the Coca-Cola Company in Niepołomice is a result of the success but not a cause of it.

Successful Activities

During the economic transformation period in Niepołomice, there have been three water preparation stations, based on the latest technology, and 150 km of water supply piping. Also, there have been modernisation works on the 17 coalfired boiler rooms, which were reconstructed with new gasfired boilers. In addition a new waste storage facility has been constructed. During the same period there has been the development of the telephone service starting from 700 phone numbers in the old manual telephone exchange to 5000 phone numbers in the modern Alcatel telephone exchange. There also has been the repair works on the purification plant, culture houses and medical care service centres.

It has also not been forgotten to establish with co-operation of the charity organisation "Caritas" the retirement house - the House of the Fine Autumn. There has also been established a special home for people suffering from "sclerosis multiplex". There is an organised annual holiday for disabled people from the area and the commune has a full culture, recreation and a health service. There is also provision and care for the young people in the form of a recreation centre, which is targeted for "green schools" environment.

The commune authorities have taken over the repair works of the Niepołomnice Castle – the pride of the town, built in XIV century. In 1991, thanks to the Mayor's efforts,

the castle has been acquired as a commune possession. For its renewing works the commune has spent a great deal of money from its own commune budget. The repair works on the castle walls have been led by the local groups according to the main rule that all work is divided between the local commune inhabitants. A new municipal institution has been established, employing its own commune inhabitants.

There has been installed, without any problem a new water supply and sewage piping. The commune inhabitants have agreed to build the sewage collectors themselves, which has been an



extra saving in the commune budget.

In the case of any inhabitants' objections, it has tried to find another solution and any objections to a project have resulted in changes. The Mayor has convinced the directors of the municipal institution that the equipment they have at their own disposal is also the common commune possession. It is important that a director can order everything that is necessary for realising the whole programme.

Nowadays Niepołomice is targeting tourism, building a water sports and holiday recreation centre in the village of Zabierzów Bocheński.

Without the development of tourism the investment in renovating the Niepołomice castle, its park and surroundings or even in the horse riding clubs, the targets would not be achieved. Due to the good location close to the old town of Krakow and its own attraction of the Niepołomice Primeval Forest there is a real chance for this project to succeed. There is also the opportunity for additional jobs or extra income from the development of the agro-tourism services.

The real trump card of the Niepołomice town and commune there are as follows:

- the arranged ground possessions:
- municipal building and industry side resources;
- present plan of the land cultivation:
- well developed local bed and breakfast services:
- high degree of industry potential concentration with the differential structure and dimensions;
- full gas and water supply piping covering the whole commune area;
- modern purification system;
- commune capital and possession in the important economic institution.

The Mayor, when often asked about the wonderful recipe for such great success, always answers that success is primary in the state of the inhabitants' mind, and they have been taught to enjoy everything they have and consequently they do not want to stop their activities.

The period of the economy and political system transformation in that commune and many other Polish ones, has caused the power to be taken over by the right people who know very well how to good manage in their communes.

Ethics in Public Administration - Prospects and Challenges of the Future for Local Governments

Conference of the School of Public Administration, Bialystok, Poland Wigry, Poland, May 4 - 6, 2000

The main aims of the conference are the exchange of scientific and practical views concerning the ethical management of public affairs and popularization of practical instruments, which have an influence on the development of the ethical infrastructure in public life. Interest in the development of ethical management is especially desirable in Central and Eastern Europe (CEE) countries where, because of political and economical transformation, mechanisms of democratic control are just being created and there exists a special awareness of corruption development.

Development of organizational and legal instruments, which have an influence on ethical management of public affairs, cannot be underestimated. This is because anybody from the outside who can appear strong and avaricious will protect the society of these countries against corruption. In this situation, confrontation of mechanisms of ethical management in the countries where democracy is well developed and CEE countries will allow us to give an answer; which one from all the mechanisms should be implemented or strengthened and developed in CEE countries.

At the international conference gathering, the academics, politicians and mass-media will have a great opportunity to popularize democratic instruments, which are developing the ethical management and consciousness of the CEE countries public functionaries (as well as Polish local authorities) in the protection of public interest and citizens' trust. The

conference can contribute to institutional changes in CEE countries, which would guarantee democratic rules.

The Conference is a forum for experts, scholars, researchers, public servants and practitioners of public administration and management in Europe and the United States. The focus of the conference will be on the state of ethics in public administration in CEE countries and, at the same time, on the challenges that public administrations in these countries will face at the beginning of the next century. Also, including the European integration process as an impetus of reform in many CEE countries. The conference's objectives are to analyze the lessons learnt, to identify the principal challenges that remain and, most importantly, to develop viable solutions.

The conference will consist of two working sessions with a direct focus on the conference theme and several working groups on topics that generated considerable interest among participants. The working sessions and working groups will be led by specialists who will run interactive discussions directed at exploring the subject and reaching conclusions regarding future research and directions. The conference languages are Polish / English.

Course objectives:

 provide an understanding of the complexities of policy-making, policy analysis and implementation through multi-disciplinary analytic frameworks which draw upon a variety of social science fields;

- offer information, knowledge, and skills on the processes, analyses, implementation, and evaluation of public policies to assist development of new courses that will educate students to work in governments, legislative bodies, and civic or business organizations:
- demonstrate how the theories of social, political, and economic values play their roles in policy making in order to use the concepts and practices of policy analysis that can lead to successful implementation and delivery;
- learn about the recent trends in the practice of public management in Western democracies, acquire usable knowledge of the evaluation of impacts and outcomes, and learn the measurement of the performance of public sector organizations;
- equip the participants with practical skills and knowledge for developing policy proposals and managing public organizations.

Course level, target audience:

The course does not require prior study of policy-making. A prospective

participant should have studied a social science discipline (e.g., economics, political science, sociology, law, etc.). Preference will be given to participants who are able to demonstrate their teaching and/or research experience in one of the empirically-oriented social science disciplines and/or economics.

Syllabus:

The first module of the course will cover the subject of values - the normative approach in the policy process. Examples of these values are social justice, efficiency, equity and equality, democratic procedures and the problem of value preferences and trade-offs, public interest, public and common good - all in the framework of collective action. The usage of these theoretical concepts in policy analysis and public management will be demonstrated and teaching cases through discussion teaching will develop the analytical skills built on these concepts.

The second module will introduce a policy-analytic framework that has the rationale of improving public policy-making in terms of social surplus. On the concept of market failures and other limitations of the competitive market in contrast to the concept of government failure will be built a set of generic policies for government. Generic policies demonstrate how almost every policy involves trade-offs - that is, a policy

may correct certain policy failures, but it also suffers from its own inherent limitations and, hence, may create new problems.

The third module will focus on models of policy designs. Special focus will be on public policies from the Czech Republic and other CEE countries with ties to cases from the CEE region presented in the first module.

The fourth module will concentrate on the organisation of public policies and transformation of ideas and methods into concrete policies. Topics will include: establishing

organisational goals and defining missions, co-ordinating across units and agencies, delegating responsibility, motivating personnel, and monitoring performance.

Course objectives:

The objectives of the course are to:

- (i) provide participants with the analytical framework for understanding intergovernmental fiscal economics and various modules of the central-subnational (e.g., local) relationship,
- (ii) enhance participants' capacity for successful implementation of public

- sector resource management reform by analysing mechanisms for the transfer of resources among governments and identifying ways to address the issue of regional disparities and local resource mobilisation,
- (iii) and increase participants, understanding in the issues of fast restructuring public economy in countries of transition.
- (iv) enhance the participants, capacity to understand and use the practical simulation methods on public finance issues (transfers, local taxes).

Course level, target audience:

The course has been designed for the practitioners, researchers/academics and trainers in the area of public finance related to local government issues and intergovernmental fiscal relations. Applicants are expected to have a basic knowledge of computer and software usage, e.g. MS Excel.

Syllabus:

Fiscal decentralization; the assignment of expenditure responsibilities; the tax assignment problem; the intergovernmental systems and grant

structure; framework for enhancing local government creditworthiness; own source revenues; Local Government Budgets, Budget purpose; Sector approach: housing; Sector approach: education; Sector approach: social policy; Sector approach: environment (water and sewage).

Assignments and assessment:

The participants will be evaluated according to their attendance and contribution to class discussions and workshop exercises. Each participant is expected to prepare a presentation on the fiscal decentralisation issues of her/his country and on the issues of one public sector. These papers will be presented during the course.

Peter Bercik, Financing of Territorial Self-governments in the Slovak Republik, Documentation of development from 1991-1997, published by the Faculty of Economics of Matej Bel University Banská Bystrica and LSGAC (Local Self-Government Assistance Center) 1999, second revised edition (English Edition).

Peter Bercik - Governmental Advisor of the Ministry of Interior of the Slovak Republic and Lecturer at the Faculty of Economics of Matej Bel University, Banská Bystrica - gives in his second edited report in 160 pages of substantial and detailed information about the Slovak Republic in general and the management of local self governments in financing operations of municipalities and administering municipal property.

In the first chapter, the author covers concise geographic, demographic and urbanistic data on settlement in the Slovak Republic. Meanwhile the second and third chapters summarize constitutional and other legal foundations, which create prerequisites for the activities of local self government and its financial system. The fourth and main chapter of the report offers a complex insight into budgetary control of municipalities. This report includes the results of financial management of municipalities for 1997 in the context of available time sequences since 1991. The presented data are based on a large number of tables and figures.

The aim of the report - to be a useful factual baseline position for other works of conceptual nature and to be an impetus for gradual further elaboration and standardization of the analytical activity of not only financial but also whole economic system of self government of municipalities in Slovakia and also abroad - is fully achieved. The detailed information about municipal budgets is in this way unique and worthy of imitation.

Therefore it would be desirable, if such serious enquiries and documentations could be published also in other Central European countries. - Just as much it could start a differentiated methodological discussion. The report may encourage to do it.

The Institute of Medical Ethics, 3rd Medical Faculty, Charles University in Prague and the School of Public Health, Institute of Postgraduate Medical Education in the Czech Republic have organised between 11th -13th November 1999 an international conference on health care reforms in some of the Central and Eastern Europe countries. For this meeting Slovakia, Hungary, Poland, Croatia, Slovenia and new counties of the FRG were included next to the Czech Republic. The aim of the conference was to focus on the broader perception of the health care reforms, emphasising and reflecting the ethical, sociological and political aspects of the reforms, which are sometimes neglected under economic and organisational and technical arguments. The intention was to exchange the information and experience with the perspective to develop a network of experts, who would continually meet.

Next to the invited speakers from the above-mentioned countries, participants from Latvia, the Slovak Republic, Albania, the Czech Republic, Hungary both from academic institutions, state administration (Health Ministry, Ministry of Finances), non-profit organisations and health insurance companies took part. People with rather theoretical views encountered those having a more pragmatic view and practical experience with the implementation of health care reforms.

The first day of the conference was dedicated to the informal introduction of speakers and participants and to present more general topics that would initiate the discussion. The conference was opened with the paper of Assoc. Prof. Jiñ Šimek, who is the head of the

Institute of Medical Ethics. He presented the issue of ethical reasoning and ethical dilemmas concerning the health care system. Following a speech from Dr. Mastilica from Andrija Stampar School of Public Health in Zagreb, Croatia that focused on equity in health resulted in an animate dispute on social justice and equitable



distribution of scarce resources. The dilemma between societal protection and individual responsibility for health and access to health care was mentioned. Apparently the idea of special attention paid to disadvantaged and marginal social groups is not automatically acceptable for everybody and surely needs more discussion and clarification.

The next day was reserved for country profiles. Invited speakers from seven countries (Prof. Soltes, Prof. Rychlik, Dr. Krizova, Prof. Forgacs, E.König, Prof. Wlodarczyk, I. Koprowska, Dr. Bitenc, Dr. Mastilica,) presented the current state, dilemmas and perspectives of next development of the health care system. It can be stated briefly, that neither the starting line of the Central and Eastern European Countries was identical. While in the most former socialist countries the state-run tax-funded health care model was implemented. In Slovenia and Croatia however, a strongly

decentralised health care system with many local funds responsible for financing the health care was in fact operating. Unlike most of countries of CEE, in Slovenia and Croatia the centralisation of financing and organising as a first step of the transformation was introduced. It can also be said that a certain border line can be observed between those countries that started their transformation immediately after the fall of communism (Slovenia, Croatia, the Czech and Slovak Republics, and the new counties of FRG) and those, that on the other hand have waited a couple of years and have introduced principal changes of their health care system only recently (Poland, Hungary). It is probable that the latter mentioned countries will face some problems resulting from the transformation in the coming period,

but it is also probable, that they will learn by the experience and faults of the others, and that some problems might be prevented.

The last day of the conference was spent with ethical, sociological, legal and philosophical reflection of selected issues, concerning the relation between the physician and patient, patients' rights and social position of physicians. Prof. Daniel Callahan from the Hastings Center,

USA, has focused on the introduction of market incentives in the health care system. Dr. Jan Payne was a speaker about the concept of social justice as it relates to the concept of natural lottery. André den Exter, a specialist in health law, outlined the legal aspects of rights and entitlements in health care. Prof. Lily Hoffman who is an experienced observer of the Czech social changes in the last decade has presented an interesting paper on the professional identification of the Czech physicians. The paper of Dr. Janeckova about the transformation problems viewed by medical professionals and discussion about the medical role in future closed the conference.

Many participants considered the idea of ongoing meetings to be challenging and some of them have preliminarily promised their participation in another meeting that is planned for May 2001.



The Role of Municipal Finance Officer's Associations in Strengthening Local Democratic Governance

November 27-29, 1999, Bratislava

Organized by The Association of Municipal Finance Officers, Slovak Republic in coordination and financial support of the Fiscal Decentralization Initiative

The pace and success of local government reforms in the region is directly linked to the issue of professionalism of the public servants. This is particularly the case of municipal finance officers that are responsible for the management of local government funds and to a certain extent bare responsibility for proper functioning of municipalities.

There are many ways of stimulating professional development of public servants. For the purpose of this project we were focused on possibilities to increase and stimulate the professional development of local government officers—specifically finance officers.

Aims:

To stimulate the establishment of some new Municipal Finance Officers Associations (MFOA) in Central Eastern Europe (CEE) and Newly Independent States (NIS) by organising this two-day international - regional conference. This conference was focused

- a) on the role of MFOA and
- b) on the key issues related to the work of municipal finance officers in CEE and NIS.

Conference objectives

to advocate the role of professional associations as stepping stones for increasing the professional capacity of municipal finance officers in CEE and NIS

- to present and discuss benefits and potential of municipal finance associations on the grounds of existing experience with similar organisations in the USA, the EU and CEE/NIS countries
- to gain interest of key municipal finance officers from CEE and NIS in the establishment of professional associations in their home countries
- to address specific professional issues of key interest to the municipal finance officers from CEE and NIS as potential areas of activity of the new associations
- to establish a nucleus of a future network of municipal finance associations in CEE and NIS

Conference Participants

The conference brought together about 100 participants from CEE, the NIS (Albania, Bosnia and Herzegovina -Federation of BiH, the Republic of Serbia, the Czech Republic, Hungary, Latvia, Macedonia, Moldova, Poland, Romania, Russia, Slovakia, Kazakhstan, Estonia and Ukraine), the EU and the USA. Most of the participants came from CEE and NIS. There were also participants from major international agencies and municipal finance associations in the EU and the USA (CIPFA, ICMA, USAID, OSI/ LGI Budapest, World Bank, and the Association of LG representatives of Finland). All participants were recognised professional leaders from the field of municipal finance.

Participants from the EU and the U.S. came from (a) institutions working on the issue of municipal finance and (b) countries with strong associations.

Summer Academy of Public Administration in Bialystok

Students from Bialystok School of Public Administration in Poland, UAPA Kharkiv Branch and UAPA Lviv Branch in the Ukraine and University of A. Kuleshov in Belarus participated in a Summer Academy Public Administration, organized in Goniadz from July 31 to August 15, 1999 and sponsored by the Open Society Institute.

They had the possibility to present and compare the public administration systems in their home countries. They could listen to interesting lectures and get or develop their knowledge of the public administration system in Poland and the United States, basics of decentralisation reform, logical and structural aspects of the State management, strategic management in local government, division of tasks, public policy, personnel policy, ethical dilemmas, reforms of education, healthcare and pension systems and globalisation of Public Administration around the world.

The participants managed to invite the best lecturers - experts on practice and theory. The most significant and famous were: prof. Dr. hab. Michał

Kulesza - Plenipotentiary of Prime Minister on Decentralisation Reform of the State. Dr. Józef Płoskonka - Vice-Minister of Interior and Administration, prof. Allan Rosenbaum - Dean of International Florida University in the USA, prof. Dr. hab. Barbara Kudrycka - Rector of Bialystok School of Public Administration, prof. Dr. hab. Stanisław Prutis - Dean of Law Faculty at Bialystok University, prof. Dr. hab. Hanna Konopka -Bialystok School of Public Administration, Dr. Viktor Vekselber - Local Government and Partnership Program. We were also thankful to the visits of our important hosts: Mr Cesar Beltran - Councillor on Culture and Promotion at the USA Embassy, Krzysztof Jurgiel -Chairman of Podlasky Seym, Dariusz Ciszewski - Vice-Chairman of Podlasky Seym, Ryszard Tur - President of Bialystok City and Marek Kozłowski - Vice-President of Bialystok City. Participants were also given the opportunity to meet students from other East Europen countries so they could exchange their views.

Most of the classes were conducted by interactive methods like discussions, panel discussions, group games, group works, and round tables. The election of local government officials e.g. the Mayor, and organs e.g. City Councils, and budgeting were presented as a two day simulation game. Participants took an active part in two Oxford debates titled: "Public officials cannot be politically neutral" and "Euro-

pean Union as a means of its members national culture".

Participants were given the opportunity to write case studies on the subject of public administration. The idea was to develop and establish interactive methods of teaching in the schools of public administration and management in the Ukraine and Belarus. The method requires materials prepared specifically to encourage discussions among students and to develope their analytic skill and professional judgment. Students of SAPA created 15 case studies which are going to be posted to schools of public administration and training institutions as teaching materials.

Participants visited Gmina Office in Goniądz, City Hall in Bialystok and the County Hall of the Podlasky Region. They met their employees and had discussions with them. Participants took part in the tour to Osowiec Stronghold, Branicky Palace in Bialystok and a canoeing trip on the Biebrza river. They watched slides of the natural environment of the Podlasky region taken by the world famous photographer, Wiktor Wołkow.

All the above mentioned activities integrated participants and created a rapport amongst them. Refering to the evaluation polls, we can say that 14 participants considered the SAPA program as very good and 10 as good. All the participants would like to return to Poland for further education in public administration.

Core themes of the Forum were introduced by keynote speakers of the opening plenary session: *Transparency, Openness and Accountability in Public Administration*, by Prof. Antonio Bar Cendon, EIPA, The Netherlands; *Transparency and Openness of Quality Democracy*, by Prof. Yehezkel Dror, The Hebrew University of Jerusalem, Israel; *Constitutional Safeguards of Legality and Legitimacy*, by Prof. Evgeni Tanchev, Sofia University Law

School, Sofia, Bulgaria; The Special Challenges Facing Governance in Transition Countries, by Dr. Imnre Forgács, Deputy Head of International Business School and Head of European Studies Departmenet, Budapest, Hungary.

The plenary was followed by two workshops focused on "Government/ Citizen Relationship", chaired by Julia Szalai, Institute of Sociology, Hungarian Academy of Sciences and "Impact of Openness on Administration", chaired by Martin Potucek, Institute of Sociological Studies, Charles University. Each workshop was opened with introductory presentations focused on the subject matter, followed by several reports from different CEE countries and a discussion between the presenters and the participants. Themes like Effective Approaches to Reform of the Government/Citizen Relationship, the Freedom of Information, Experience with Citizens' Charters, the Role of NGOs, Interest Groups as Mediators between Government and Citizens, International Experiences of Results of Open Government, Legislating for Openness, the EU Experience, the Role of Government Information Offices, and the Perspective from Candidate Countries were addressed by speakers and discussed.

The workshops were followed by a round table discussion concentrated on "Implementing Transparency and Openness in Governance" and chaired by Isabel Corte-Real, Director General of EIPA.

The Forum was finalised by the closing plenary session chaired by Martin Potucek, Charles University and Mirko Vintar, University of Ljubljana, who in the concluding remarks identified several key domains generated from discussions. All materials of the Forum will be published in the proceedings and disrtributed in the region.

Meeting of the Standing Working Group on Politico-Administrative Relations

held at the UNDP Regional Support Centre, Bratislava, November 7-8, 1999

Chairpersons: Tony Verheijen and Aleksandra Rabrenovic

The working group on politicoadministrative relations met in Bratislava on November 7-8 to discuss 'work in progress'. The meeting was funded by OSI/LGI, which has made

OSI/LGI, which has made available a grant to support the operation of the working group for the current academic year. The meeting focused on four main issues:

- Developing a tailormade research methodology for comparative studies on politicoadministrative relations in the states in transition
- Discussion of ongoing country studies on politico-administrative relations at central government level
- Starting the study of politicoadministrative relations at local government level
- Development of thematic studies

The discussions on the development of a tailor-made research methodology were based on the work carried out by two members of the group, Jan Meyer-Sahling (LSE) and Alexander Kotchegura (Moscow State University). The debate on the two models proposed will eventually lead to an adaptation of the research protocol, which had initially used the comparative frameworks of Heady and Peters, which were not really deemed applicable in the specific context of transition.

The country studies on central government politicoadministrative relations are by now sufficiently developed to be ready for discussion in the NISPAcee annual conference in Budapest and for publication in a NISPAcee textbook, planned



for completion in the summer 2000. Country studies are ongoing on Bulgaria, Czech Republic, Estonia, Kyrgyzstan, Latvia, Lithuania, Romania, Russia, Slovakia and Yugoslavia.

The group spent considerable time on a discussion on how to develop local government studies on politico-administrative relations. Two of the members of the group, Vesselina Kolcheva (FLGR, Bulgaria) and Tamas Horvath (IPA, Hungary) agreed to adapt the research protocol, which governs the research work on country studies, in line with the discussion at the meeting. A small number of pilot studies will be presented at the conference in Budapest in one of the working group sessions. Furthermore, it was decided that the development of studies on politico-administrative relations on local government would be the main theme for the 2001 conference sessions. Pilot studies are being prepared on

Bulgaria, Hungary, Lithuania, Romania, Slovakia, Ukraine and Yugoslavia. The working group will in particular welcome

> proposals in this area at the Budapest conference sessions.

> The final substantive point was the development of thematic studies. Ongoing studies on the impact of professionalisation on politico-administrative relations (Wyman and Kovriga) and on modalities for the delivery of

policy advice (Lazareviciute and Verheijen) were discussed. Further proposals for the development of thematic studies would be welcomed by the working group.

The group also discussed other matters, such as the organisation of the Working Group sessions for the Budapest conference and the structure and time schedule for the completion of the future textbook.

This intermediate meeting was extremely useful to focus the minds of the group in between the two annual conferences and also to further develop the 'group spirit', which has been getting ever better during our two years of joint work. We are therefore most grateful for the grant of OSI/LGI which made the meeting possible.



The 8th NISPAcee Annual Conference
